What data will we collect about you?

Each year, the School Workforce Census requires us to collect the following data from schools:

- Full name
- National Insurance number
- characteristics such as ethnic group and gender
- employment contracts
- remuneration details
- qualifications
- information about absences

What will we use your data for?

We process personal data relating to those we employ to work at schools that are controlled by West Berkshire Council as the Local Education Authority.

The collection of this information will benefit both national and local users by:

- Improving the management of workforce data across the sector
- Enabling development of a comprehensive picture of the workforce and how it is deployed
- Informing the development of recruitment and retention policies
- Allowing better financial modeling and planning
- Enabling ethnicity and disability monitoring; and
- Supporting the work of the School Teachers' Review Body

The workforce data that we lawfully share with the Department for Education through periodic data collections:

- informs departmental policy on pay and the monitoring of the effectiveness and diversity of the school workforce
- links to school funding and expenditure
- supports 'longer term' research and monitoring of educational policy

Who will see your data?

- West Berkshire Council
 Schools are required to share information about workforce members with their local authority (LA) by law. This information comprises the basis of the census return to the DfE. Access to the data is strictly controlled and only extended to specific members of staff with the correct training and expertise.
- the Department for Education (DfE)
 The School Workforce Census return is submitted and approved by West Berkshire Council to the Department for Education (DfE).

Why are we Doing This?

West Berkshire Council is processing the data it receives as part of the School Workforce Census according to the legal obligation placed on it by section 5 of the Education (Supply of Information about the School Workforce (England) Regulations 2007 and amendments).

As such, there is no legal right to refuse processing as we are legitimately required to do this by UK law. You have certain rights when it comes to your data; there's more on thesee below (see "Your Rights").

How long will your data will be kept?

Your data will not be kept any longer than necessary. You can check how long the organisation will keep each type of data against West Berkshire Council's retention schedule (www.westberks.gov.uk/retention).

The data will only be held by West Berkshire Council for the duration of the transfer to the Department for Education; after this it is securely and permanently deleted.

How is your data stored and processed?

Your data will be held on COLLECT, the portal used for processing data collection returns and will be protected using up-to-date technical and organisational security measures.

Transfer overseas

Your data will not be stored or sent outside of the UK.

Your rights

Complaints
