

## West Berkshire Council CIL Monitoring Report 2016/2017

CIL took effect on all approvals granted from 1 April 2015. 2015/2016 was the first financial year in which CIL was charged and the first year in which CIL payments were collected. No expenditure of CIL has yet taken place.
